During her time on the project Markéta undertook the following tasks:

Control of accounts

The project had a total budget of 1.2m Euros. Much of that expenditure was controlled in Prague. Markéta had overall responsibility for controlling the expenditure for the three separate teams within our project. She devised accounting systems that had to meet EU and English Ministry requirements. On a day-to-day basis Marketa would ensure that expenditure was properly recorded, had been spent in accordance with the rules and liase with colleagues in England ensuring accurate records were available.
